






YTD March 2018 Revenue

Average Project Size: \$0.6 M | Average Project Length: 6-9 months





Adjusted EPS/Stock Price History






Historical Financial Summary




Profile for Growth




Average Discretionary Spending

Note 4: Correction of prior period accounting errors in 2013 resulted in net after-tax income of approximately \$1.3 million, or \$0.03 per diluted share.
