# Q2 2026 FINANCIAL RESULTS HIGHLIGHTS

Q2 2026 Revenue was \$3.27 billion compared to \$2.17 billion in Q2 2025

Gross Profit percentage increased to 25.9% vs. 23.5% in Q2 2025

SG&A increased to \$287.0 million from \$210.5 million in Q2 2025

EPS was \$12.53 per diluted share compared to \$6.53 in Q2 2025

Q2 2026 Cash Flow from Operations was \$1.14 billion compared to \$252.5 million in Q2 2025

Q2 2026 Backlog was \$14.06 billion compared to \$12.45 billion in Q1 2026 and \$8.12 billion in Q2 2025

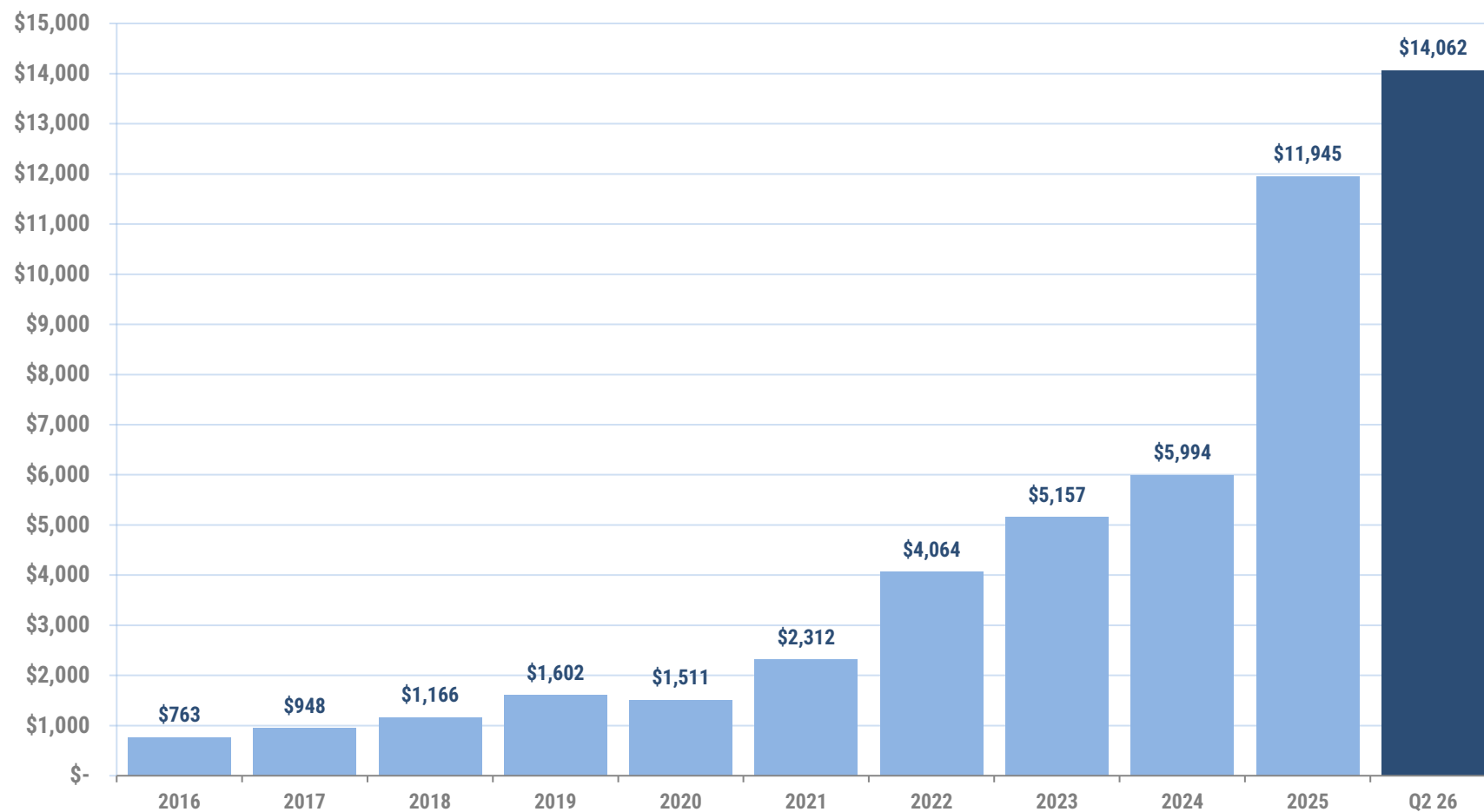

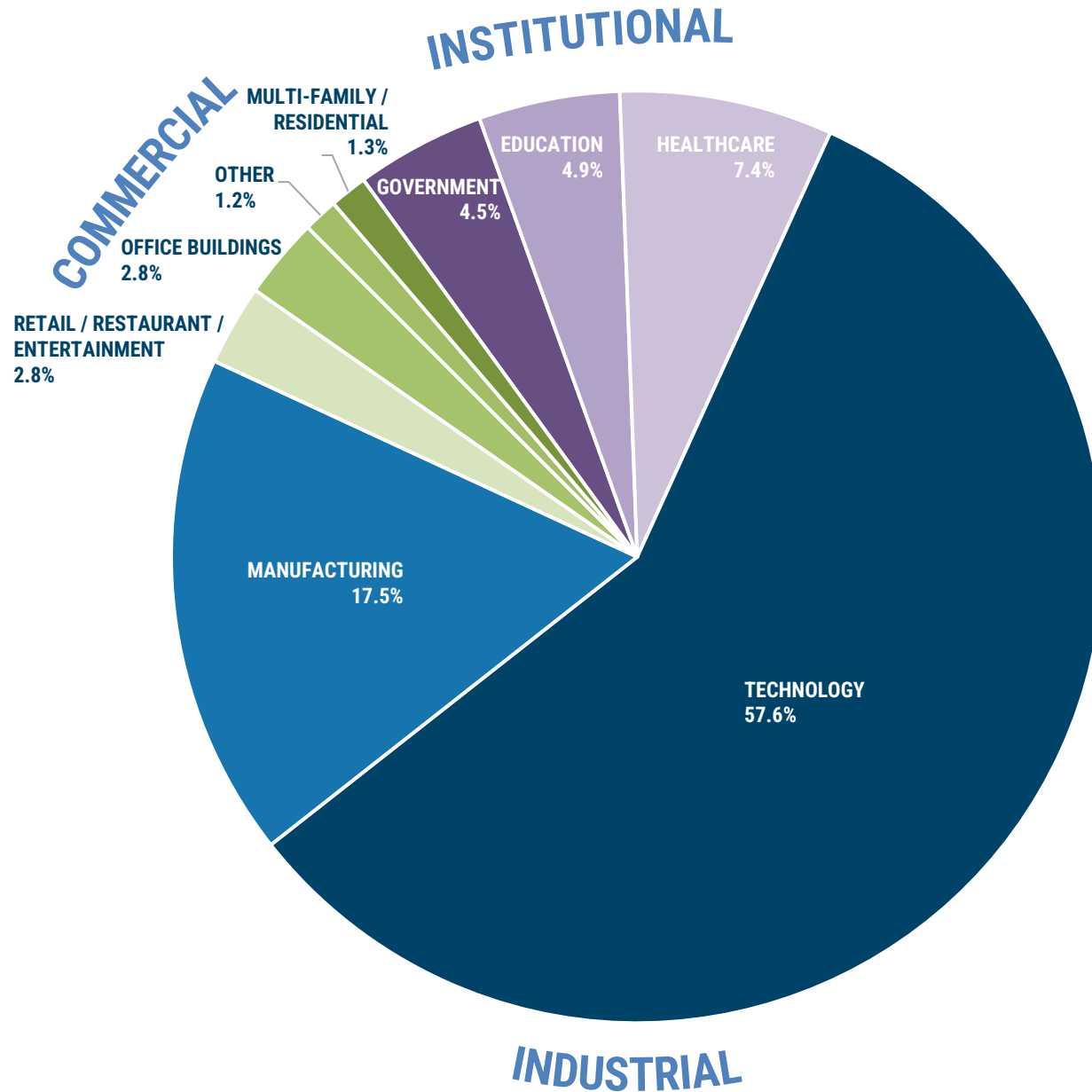
# BACKLOG

(\$ Millions) (Unaudited)



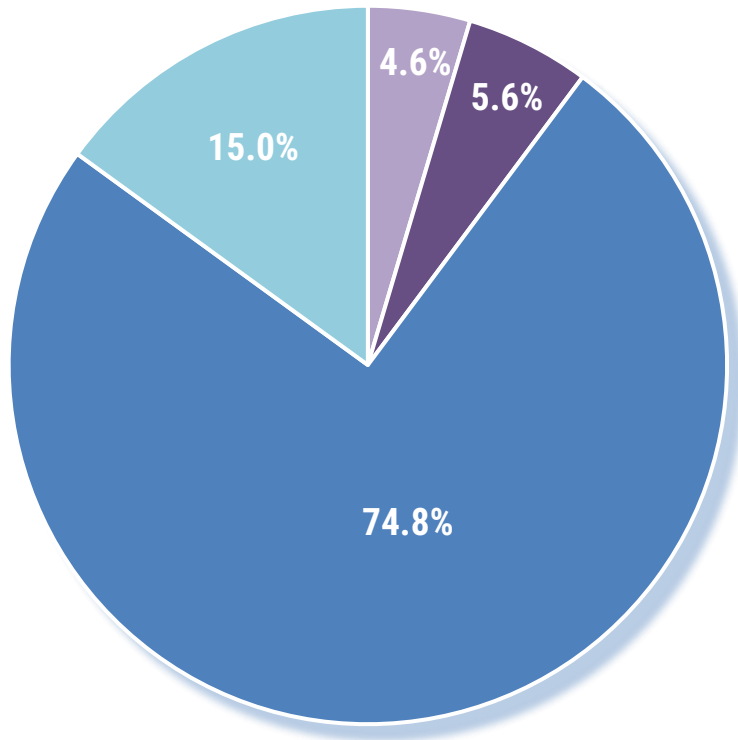
# REVENUE BY TYPE OF CUSTOMER

(YTD)

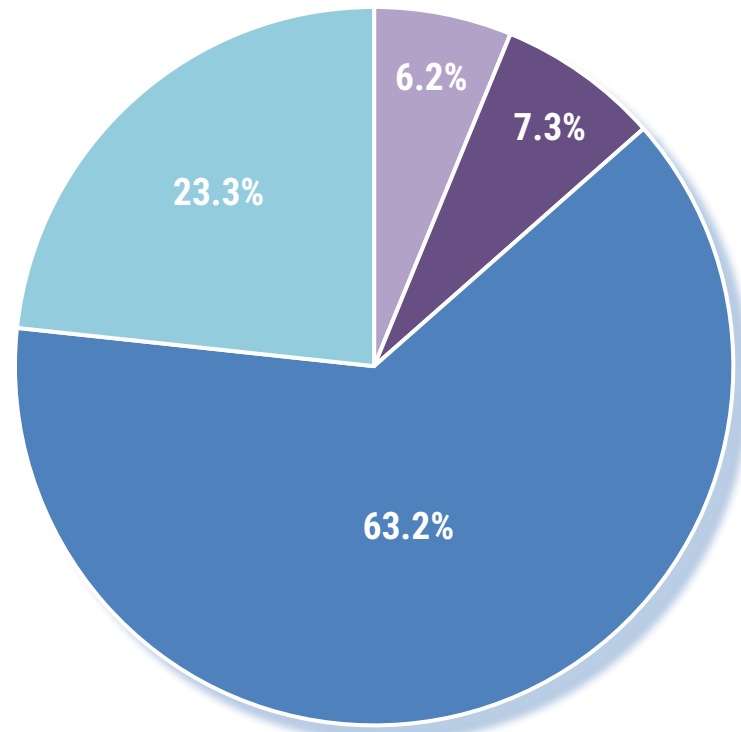


# REVENUE BY ACTIVITY TYPE
