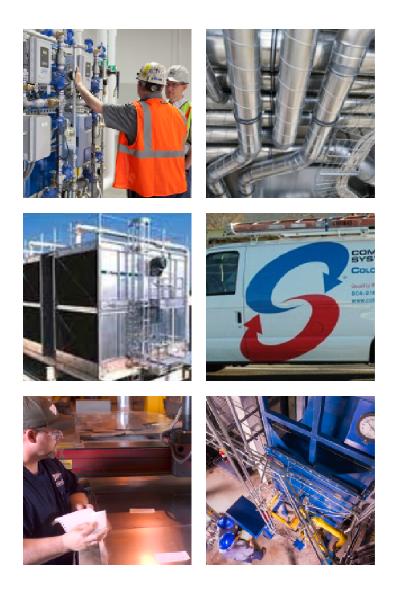

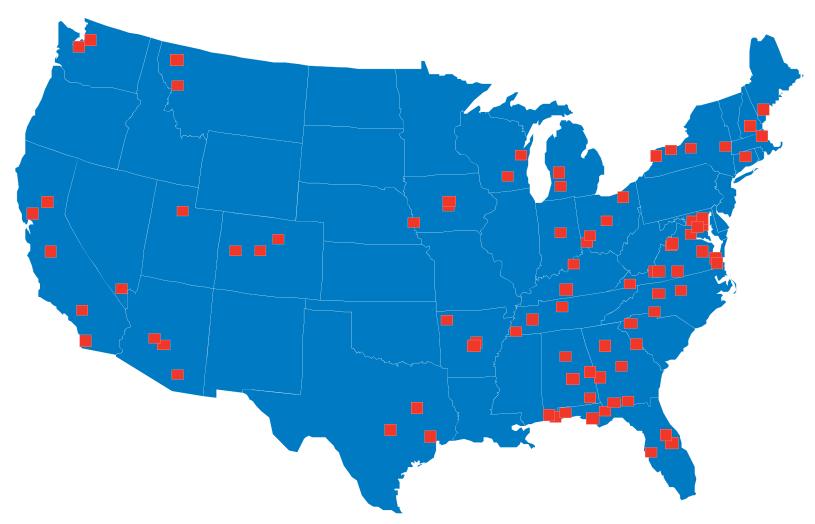

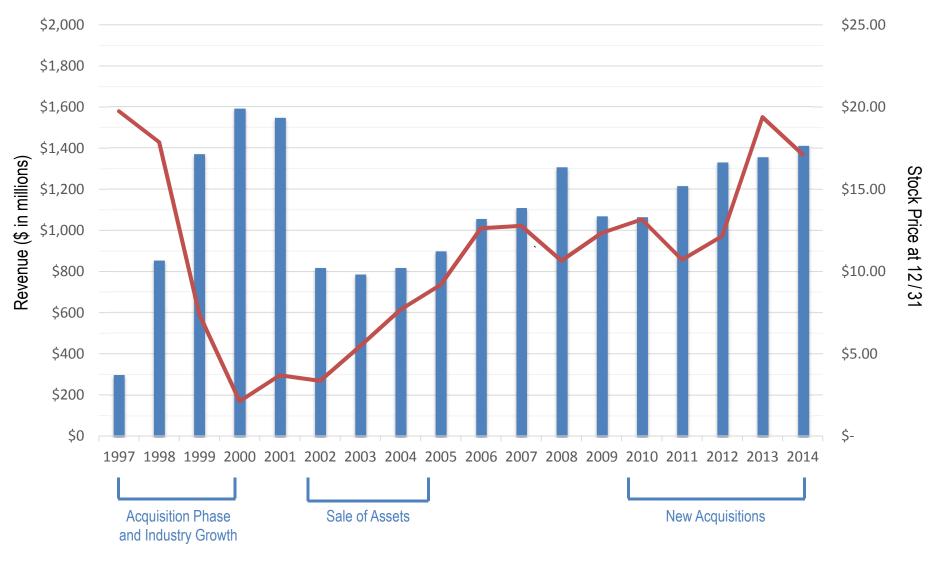
## **Broad Nationwide Footprint**

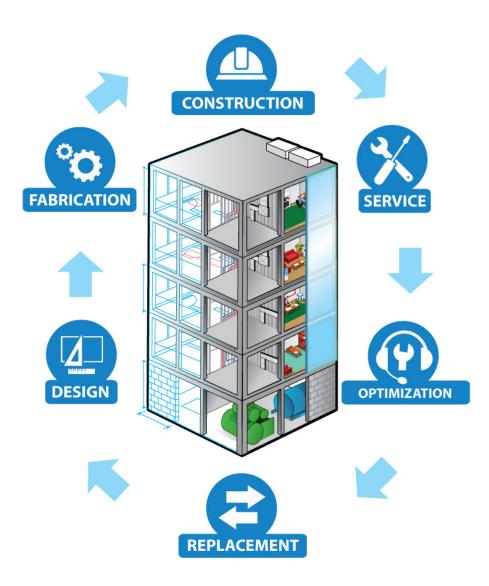


## **Revenue/Stock Price History**





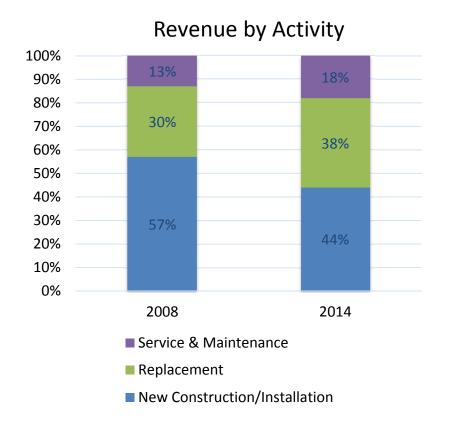

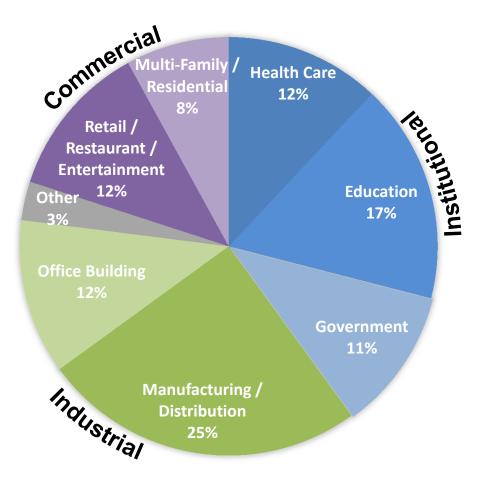

## **Market Sectors**



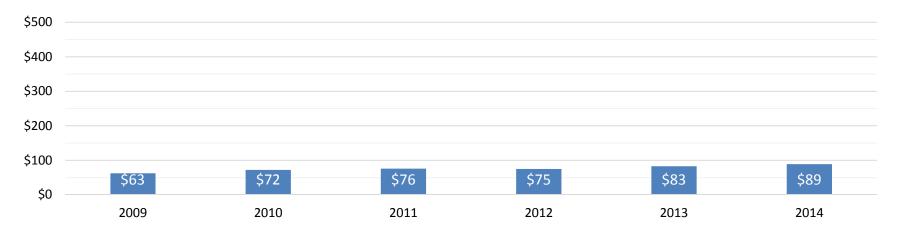
#### **December 2014 YTD Revenue**

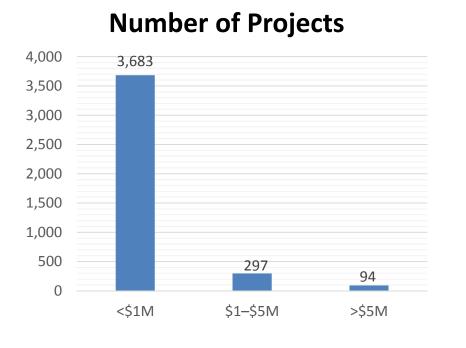
#### **Service Maintenance Base**



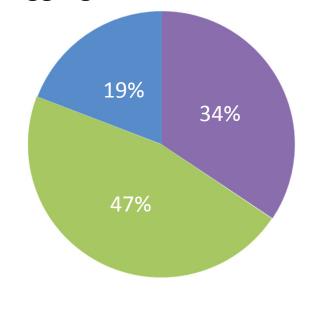

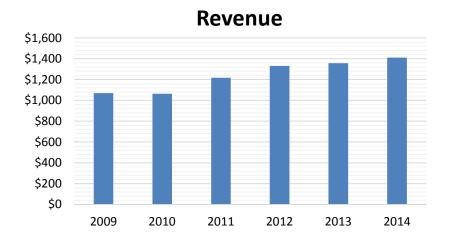

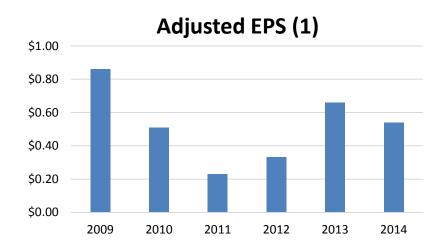

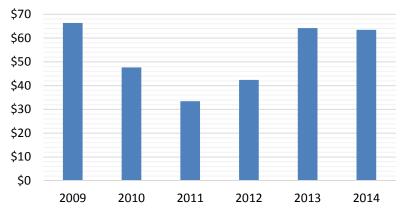

# Solution Cash Flow Solution Control Co



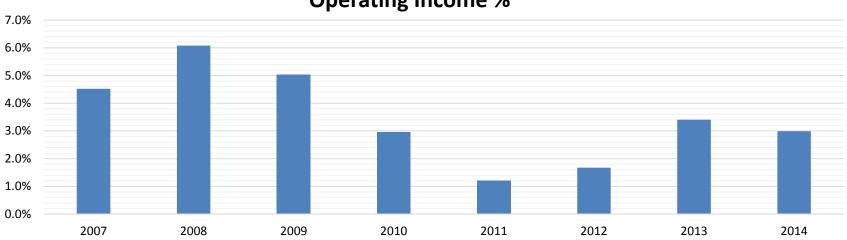
#### Adjusted EBITDA (2)

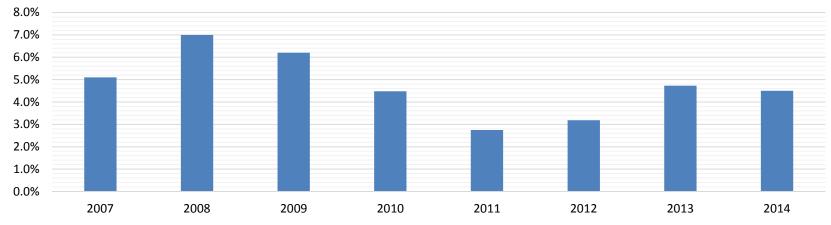


## **Historical Financial Summary**

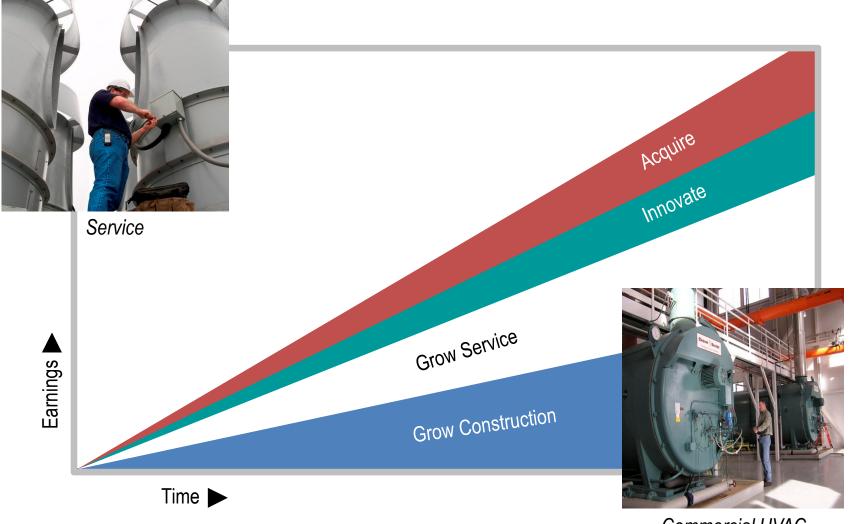

Note 4: Correction of prior period accounting errors in 2013 resulted in net after-tax income of approximately \$1.3 million, or \$0.03 per diluted share.
