# Q4 2022 FINANCIAL RESULTS HIGHLIGHTS

Q4 Revenue was \$1,117.2 million compared to \$856.1 million in Q4 2021

Gross Profit percentage increased to 18.9% vs. 18.0% in Q4 2021

SG&A increased to \$131.7 million from \$105.3 million in Q4 2021

EPS was \$1.54 per diluted share compared to \$1.04 in Q4 2021

Q4 2022 Cash Flow from Operations was \$132.0 million compared to \$27.5 million in Q4 2021

Q4 2022 Backlog was \$4.06 billion compared to \$3.25 billion in Q3 2022 and \$2.31 billion in Q4 2021

# 2022 FINANCIAL RESULTS HIGHLIGHTS

2022 Revenue was \$4.14 billion compared to \$3.07 billion for 2021

Gross Profit percentage decreased to 17.9% from 18.3% for 2021

SG&A increased to \$489.3 million from \$376.3 million for 2021

EPS was \$6.82 per diluted share (\$5.29 per diluted share excluding a \$1.53 benefit related to tax gains) compared to \$3.93 for 2021

2022 Cash Flow from Operations was \$301.5 million compared to \$180.2 million for 2021

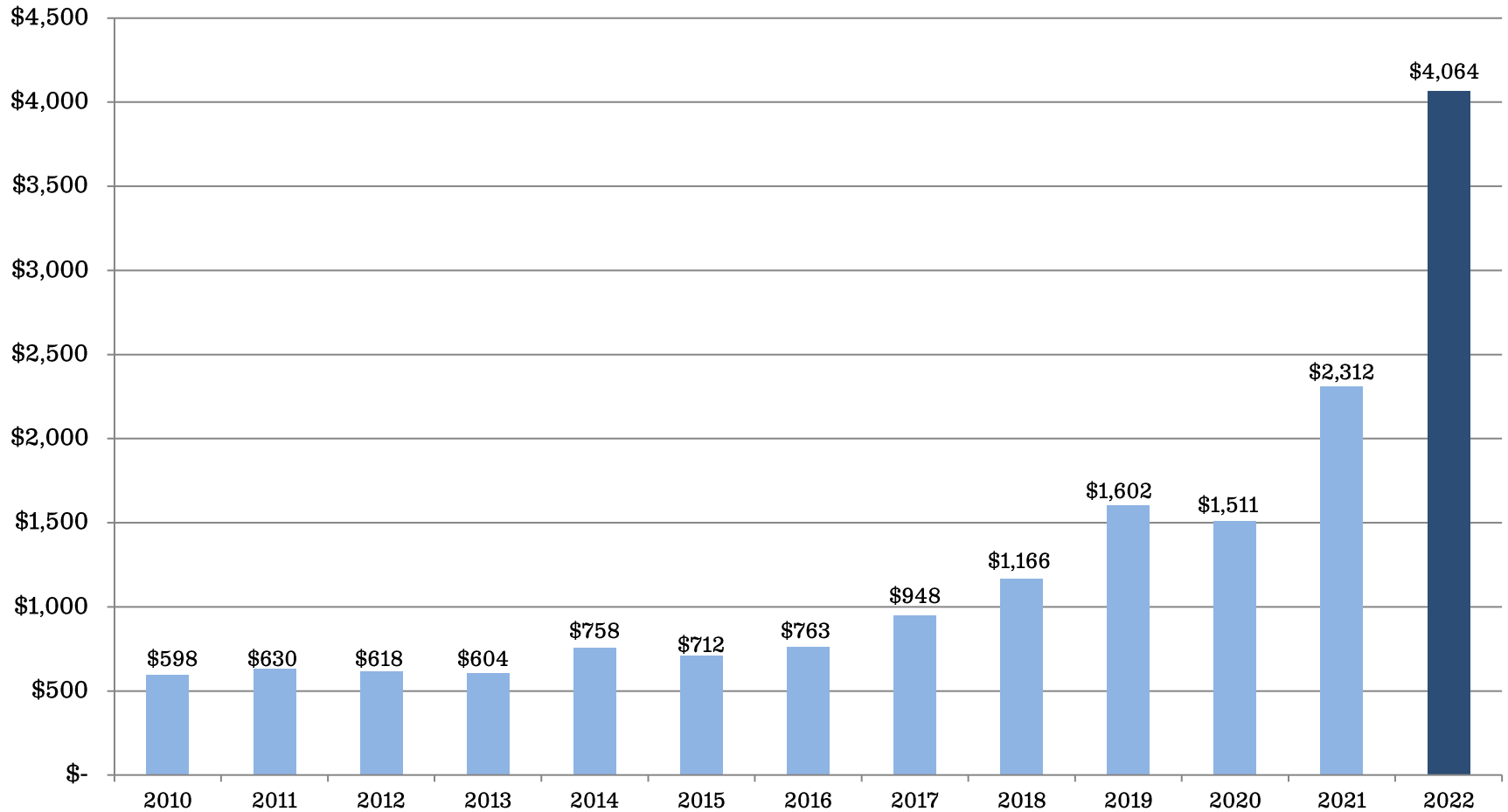

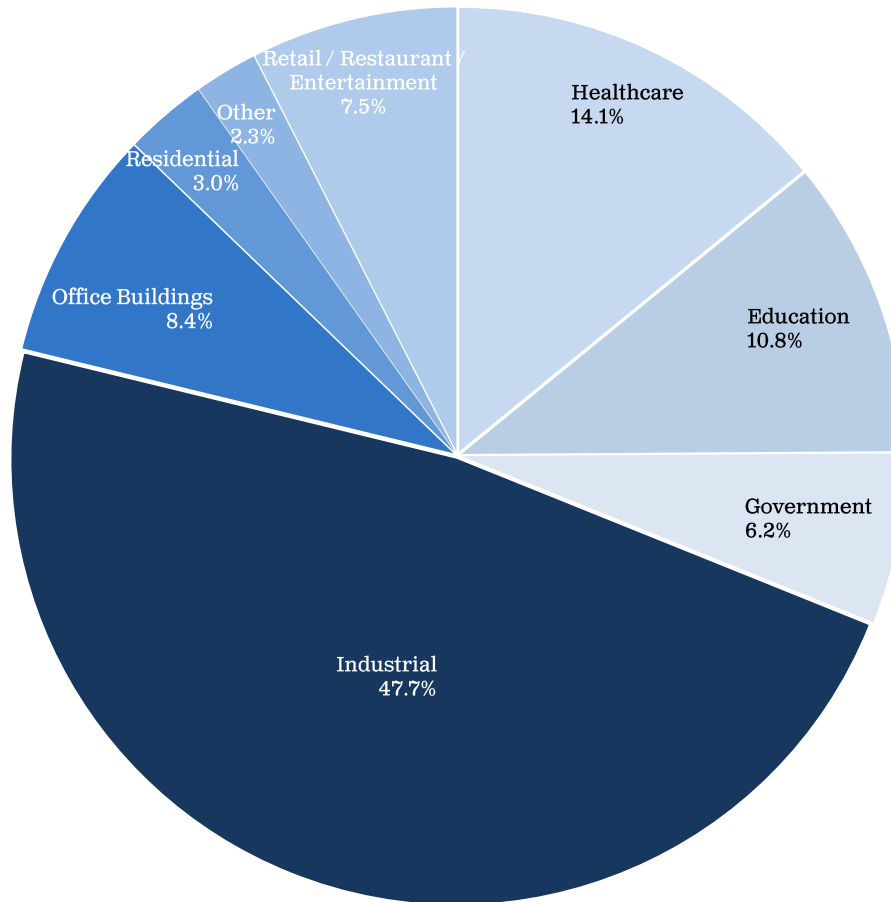

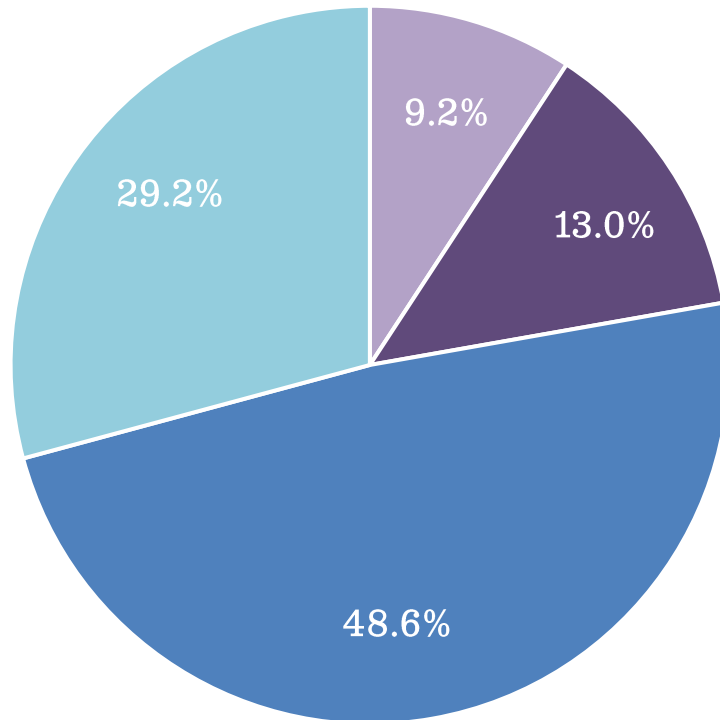
# REVENUE BY TYPE OF CUSTOMER

(YTD)

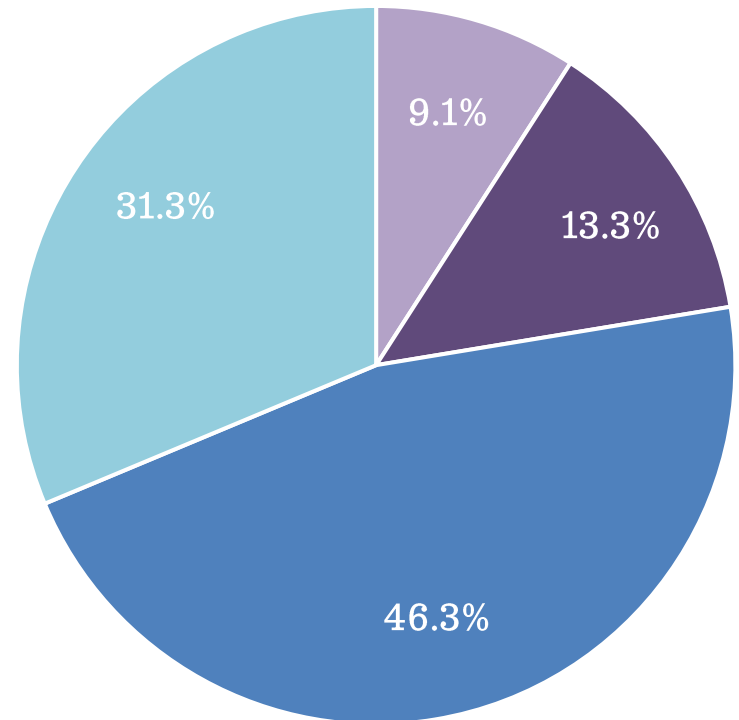


# REVENUE BY ACTIVITY TYPE
